CREATE A LASTING IMPACT

Planning your estate is a thoughtful process, and it's a wonderful time to reflect on what truly matters to you. By including Butte Humane Society in your planned gifts, you're making a powerful statement about your commitment to animal welfare. There are many ways to leave a gift and you should work with your attorney or financial advisor to determine what is best for you and your family. Here are just a few examples with sample language.

- **Bequest by Will or Trust**

- Percentage of your estate
 - [Sample language: I give and bequeath ___% of my estate to Butte Humane Society, a 501(c)(3) nonprofit organization whose principle office is currently located at 13391 Garner Ln, Chico CA 959793, Tax I.D. # 94-1580621.]
- Specific dollar amount
 - [I give and bequeath the sum of \$___ to Butte Humane Society...]
- Gift of property
 - [I give my property located at ___ to Butte Humane Society...]
- Residuary bequest
 - [I give and bequeath all (or ___%) of the residue of my estate to Butte Humane Society...]
- Contingent gift
 - [If (name of beneficiary) does not survive me, I give the residue of my estate to Butte Humane Society...]

- **Donor Advised Fund** | If you have a Donor Advised Fund established, you may recommend a donation to Butte Humane Society.

- **Gift of Retirement Benefits** | If you are at least 70 ½ years old, you may direct your required minimum distribution from your IRA to Butte Humane Society. Qualified charitable distributions are not taxed.
